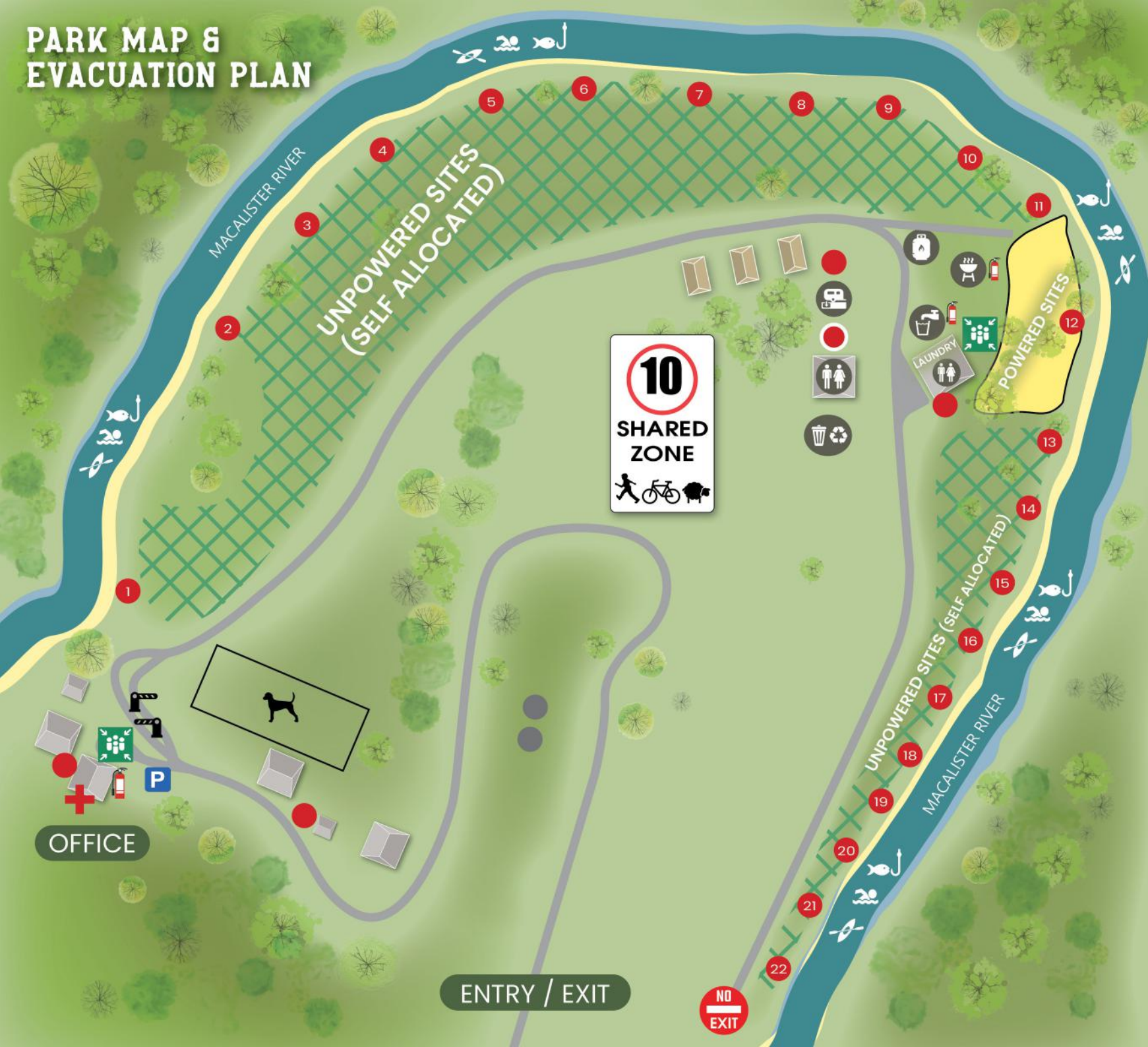

EMERGENCY EVACUATION PROCEDURE

2. TURN OFF GAS AND ELECTRICITY TO YOUR SITE
3. SECURE YOUR VALUABLES
4. MOVE TO EMERGENCY EVACUATION AREAS
5. WAIT FOR INSTRUCTIONS FROM AUTHORITIES

CHECK IN/OUT

Cabins	After 2pm	By 10am
Powered & Unpowered Sites	After 12pm	By 10am

Check-ins between 6–9pm by prior arrangement only.

The road into the property is unsealed, inclined and narrow. For safety and to minimise vehicles meeting on this road, please adhere to check in/out times.

QUIET TIME

Quiet Time in the Park is 10pm–8am

SITE SETUP

For safety:

- Fire pits must not be moved
- Draw bars should face the roadway

Please park vehicles back from the river to ensure river access for all.

VEHICLES

Speed limit within the Park is 10kmph. All vehicle passengers must wear a seat belt. Vehicles are not to approach or cross the river. Motorbikes, e-scooters, e-bikes and drones are not permitted. Helmets are to be worn when riding bicycles. No riding bicycles after dark.

ELECTRIC VEHICLE CHARGING

The nearest EV charging station is Apex Park Heyfield (21km). CFA regulations prohibit charging of electric vehicles in our Park.

BEHAVIOUR

The following behaviours are not acceptable and may result in immediate eviction from the Park

- Bullying/threatening/disturbing/harassing of guests, staff or animals
- Damaging property or littering
- Excessive noise, noise during Quiet Time
- Excessive speed (10kmph speed limit)
- Dangerous use of property, the river or campfires

Management reserves the right to refuse entry or evict any person at anytime.

VISITORS

We do NOT allow day visits for picnics, BBQs, swimming, sightseeing, etc. Guests of the Park are permitted to have family and friends visit (fee applicable) when Management has been informed beforehand. All visitors must check-in at the office and must leave the park by 8pm. We do not allow visitors during Xmas/January, Labour Day, Easter, ANZAC Day, King's Birthday, AFL Grand Final, Melbourne Cup.

GENERATORS

Intermittent use of generators is permitted between 8am–8pm.

RIVER

The river and surrounds are used at own risk.

CAMPFIRES

Campfires are permitted when conditions and authorities allow. A bucket of water must be located next to the fire at all times.

Fires MUST be:

- In the park drums provided (fire pits must NOT be moved),
- Extinguished when wind exceeds 10kmph or upon Management request
- Extinguished prior to going to bed and/or leaving your site
- Supervised by an Adult (18+) at all times
- Left with ashes in drum and leftover wood neatly stacked beside

Fires must NOT be:

- left unattended
- ignited without first checking the restrictions of the day
- Used to dispose of any rubbish
- Emptied of ashes – contact staff to do so

Firewood:

- Can be purchased at the office
- Can be brought into the park from home in small quantities (no trailer loads)
- Cannot be delivered to the park by third parties
- Cannot contain nails or bolts
- Must not overhang the fire drum (max length 55cm)
- Only 30kg of firewood should be unloaded or stored near the fire

PETS

Pets are permitted on sites (cats and dogs only).

The maximum number of pets is 2 per site.

Pets are not allowed in cabins, BBQ areas, amenities or the office.

Pets must be kept on a leash AT ALL TIMES (except for in the designated off leash area).

You must attend to noisy pets immediately to ensure other guests have quiet enjoyment of the park.

All droppings must be collected and disposed of immediately in the park rubbish skips.

Pets must not be left unattended at any time – you must take your pets with you when you leave your site.

Pets must not interfere with, or menace: guests, staff, farm livestock, native fauna or other pets.

Management reserves the right to reject any pet or ask them to be removed from the park immediately without explanation.
